Rate Protection Plan

Here is a sample pricing adjustment required to determine your interest rate ceiling or discount:

Rate Sheet Indication	3.750% @ - 1 point
RPP Adjustment for 5 month float down	.375 + 0 points
Maximum or Capped Rate	4.125% @ - 1 point
